

STATEMENT OF WORK (SOW)

NSN 6130-01-035-9254

1.0 Scope. This SOW identifies the work effort that shall be performed by the Contractor to repair the Static Frequency Converter NSN 6130-01-035-9254, part number 77C719261P3/CAGE 03538. This document contains requirements to restore the Static Frequency Converter to Condition Code "A." Condition Code "A" is defined as "serviceable/issuable without qualification; new, used, repaired or reconditioned material that is serviceable and issuable to all customers without limitation or restriction, including material with more than 6 months shelf-life remaining.

### 3.0 Requirements

3.1 The Contractor shall repair the Frequency Converter strictly in accordance with the requirements as specified in 77C719261/CAGE 03538. The Contractor will be responsible for developing the test requirements

### 3.2 Packaging, Handling, Storage and Transportation

3.2.1 The Contractor shall be responsible for preservation and packaging of items being repaired under the terms of this statement of work in accordance with MIL-STD-2073-1C, Appendix A, Table A.VI, Electronic Equipment. Items scheduled for long term storage or shipment to overseas destinations shall be packaged in accordance with Level "A" requirements. Items scheduled for domestic shipment and short-term storage shall be packaged in accordance with Level "B" requirements.

3.2.2 Marking shall be in accordance with MIL-STD-129.

3.2.3 The Marine Corps will provide the Contractor with the shipping address(es) for, and delivery of the repaired equipment. The Contractor shall be responsible for arranging for shipment to the pre-designated site(s). The Marine Corps will be responsible for transportation costs associated with shipping and the subject equipment to and from the Contractor.

3.3 Configuration Control. The contractor shall apply configuration control to established configuration items. Deviations from this established baseline configuration shall not be allowed without the express written approval of the Weapon System Manager (WSM) (Code 844-2). All permanent changes to the form, fit or function of the baseline shall be by Engineering Change Proposal. MIL-STD-973 (paragraph 5.4.2 and Appendix D) may be used as a guide. If necessary to temporarily depart from the authorized configuration baseline, the contractor shall prepare and submit a Request for Deviation or Request for Waiver. MIL-STD-973 (paragraph 5.4.3 or 5.4.4 and Appendix E) may be used as a guide.

3.4 Government Furnished Equipment (GFE) and Government Furnished Materiel (GFM). GFE is government owned equipment authorized by contract for use by a commercial/Government contractor. It is neither consumed during production nor incorporated into any product. GFM is materiel furnished to a contractor that will be consumed during the course of production or incorporated into the product being manufactured/remanufactured under a contract/statement of work. In the event the Marine Corps does have GFE/GFM requirements, the Management Control Activity (MCA/G316-2), Marine Corps Logistics Bases, Albany, Georgia, will coordinate required GFE and will maintain a central control on Marine Corps assets in the Contractor's

possession. The MCA will forward a GFE accountability agreement to the Contractor Facility for signature to establish a chain of custody and property responsibilities for Marine Corps assets. The Contractor shall report receipt of all GFM and report consumption of GFM to the MCA.

3.5 Quality Assurance Provisions. The Contractor shall provide and maintain a Quality System that, as a minimum, adheres to the requirements of ANSI/ISO/ASQC Q9003-1994, Quality System Model for Quality Assurance in Final Inspection and Test.

4.0 Reports. The Contractor shall develop a Test Data Report (TDR), based on test requirements developed by the Contractor (para. 3.1), which references this SOW, the NSN, part number, and serial number of the Frequency Converter and all sub-assemblies. Upon request, a copy of the TDR shall be submitted electronically (preferred), via regular mail, or facsimile to the WSM.
