### 1.0 Scope

This document contains requirements to restore the M2A2 Aiming Circle to condition code 'A'. Condition code 'A' is defined as serviceable/issuable without qualification, new, used, repaired, or reconditioned material which is serviceable and issuable to all customers without limitation or restriction.

1.1 This Statement of Work (SOW) identifies the work effort that shall be performed by the contractor to rebuild the M2A2 Aiming Circle ID# 00476C, TAMCN E01807, NSN 6675-01-067-0687.

2.0 Applicable Documents The following documents form a part of this SOW to the extent specified. Unless otherwise specified, the issues of these documents are those listed in the Department of Defense Index of Specifications and Standards (DoDISS) and supplement thereto which is in effect on the date of solicitation. In the event of conflict between the documents referenced herein and the contents of this SOW, the contents of this SOW shall be the superseding requirement.

### 3.0 Requirements

#### 3.1 Rebuild.

The contractor shall use the following documents to assist in the rebuilding of the Aiming Circles: TM 00476C-24&P w/chg 1 dtd 29 Jan 99, TM 9-1290-262-10, and DMWR 9-1290-262.

Upon completion, rebuilt Aiming Circles shall be in Condition Code "A", as described in paragraph 1.0 to this SOW.

#### 3.2 Quality Assurance/Quality Control

The Contractor shall provide and maintain a Quality System that as a minimum, adheres to the requirements of ANSI/ISO/ASQC Q9002-1994, Quality System Model for Quality Assurance in Production, Installation, and Servicing. Quality acceptance and test procedures shall be in accordance with TM 00476C-24&P w/chg1, dtd 29 Jan 1999 chapter 4, section III, paragraph 4-4, page 4-16.

#### 3.3 Configuration Control

If necessary to temporarily depart from the authorized Repair Parts List, established in TM 00476C-24&P w/chg1, dtd 29 Jan 1999, the Contractor Facility shall prepare and submit a Request for Deviation or Request for Waiver. MIL-STD-973 (paragraphs 5.4.3 or 5.4.4 and Appendix E) may be used as a guide.

#### 3.4 Packaging, Handling, Storage and Transportation (PHS&T)

a. The Contractor shall be responsible for preservation and packaging of items being repaired under the terms of this statement of work. Items being prepared for long term storage or shipment to overseas destinations shall be packaged and preserved in accordance with SPI AM P11785090 which may be obtained from G3 Logistics Operations Department, Attn: S&DD

(G330), 814 Radford Blvd., Suite 20330, Albany, GA. 31704-0330, Commercial (912) 439-6856 or DSN 567-6856. Items being prepared for domestic shipment or immediate use shall be in accordance with level "B" requirements.

b. Marking shall be in accordance with MIL-STD-129.

c. The Marine Corps will provide the contractor with the shipping address(es) for delivery of the repaired equipment. The contractor shall be responsible for arranging for shipment to the pre-designated site(s). The Marine Corps will be responsible for transportation costs associated with shipping the subject equipment to and from the contractor.

### 3.5 Government Furnished Equipment (GFE)/Government Furnished Materiel (GFM)

GFE is government owned equipment authorized by contract for use by a commercial/ Government Contractor. It is neither consumed during production nor incorporated into any product. GFM is materiel furnished to a Contractor that will be consumed during the course of production or incorporated into the product being manufactured/remanufactured under a contract/ statement of work. In the event the Marine Corps does have GFE/GFM requirements the Management Control Activity (MCA/G316-2), Marine Corps Logistics Bases, Albany, Georgia, will coordinate required GFE and will maintain a central control on Marine Corps assets in the Contractor's possession. The MCA will forward a GFE Accountability agreement to the Contractor Facility for signature to establish a chain of custody and property responsibilities for Marine Corps assets. The Contractor shall report receipt of all GFM and report consumption of GFM to the MCA.

3.6 Contractor Furnished Materiel The Marine Corps has adopted the Navy's procedures regarding Contractor Furnished Materiel (NAVICPINST 4491.2A.) In the event that Contractor Furnished Materiel is required for repair parts, the contractor shall requisition through the DOD Supply System. DOD 4000.25-1-M, (MILSTRIP) Chapter 11 authorizes contractors to requisition through the DoD Supply System.
