1.0 SCOPE. This document contains requirements to restore the Light Armored Vehicle Control Arm Assembly, Left to Condition Code "A". Condition Code "A" is defined as serviceable/issuable without qualification, new, used, repaired, or reconditioned material which is serviceable and issuable to all customers without limitation or restriction.

1.1 Background. This Statement of Work (SOW) identifies the work effort that shall be performed by the contractor (for the purposes of this SOW, contractor is defined as the commercial or government entity performing the repair) to repair the Control Arm Assembly, Left, NSN 2530-01-166-0626 in support of the Light Armored Vehicle.

3.0 REQUIREMENTS.

3.1 GENERAL TASKS. The contractor shall repair the Control Arm Assembly in accordance with TM 08594A-34/9. A complete parts breakdown of the Control Arm Assembly can be found in SL-4-08594A. All Control Arm Assemblies repaired shall have a data plate installed in accordance with TI-4700-45/6A.

3.1.1 Government Furnished Equipment (GFE)/Government Furnished Materiel (GFM). GFE is government owned equipment authorized by contract for use by a commercial/Government contractor. It is neither consumed during production nor incorporated into any product. GFM is materiel furnished to a contractor that will be consumed during the course of production or incorporated into the product being manufactured/remanufactured under a contract/statement of work. In the event the Marine Corps does have GFE/GFM requirements the Management Control Activity (MCA/827-2), Marine Corps Logistics Bases, Albany, Georgia, will coordinate required GFE and will maintain a central control on Marine Corps assets in the Contractor's possession. The MCA will forward a GFE Accountability agreement to the Contractor Facility for signature to establish a chain of custody and property responsibilities for Marine Corps assets.

3.1.2 Contractor Furnished Materiel (CFM). The Marine Corps has adopted the Navy's procedures regarding Contractor Furnished Materiel (NAVICPINST 4491.2A). In the event that Contractor Furnished Materiel (CFM) is required for repair parts, the contractor shall requisition repair parts through the DoD Supply System. DoD 4000.25-1-M (MILSTRIP), Chapter 11 authorizes contractors to requisition through the DoD Supply System.

3.2 QUALITY ASSURANCE PROVISIONS. The contractor shall provide and maintain a Quality System that as a minimum, adheres to the requirements of ANSI/ISO/ASQC/ Q9003-1994 Quality Systems Model for Quality Assurance in Final Inspection and Test.

3.3 CONFIGURATION CONTROL. The contractor shall apply configuration control procedures to established configuration items. The contractor shall not implement any changes to an item's documented performance or design characteristics without receiving prior written authorization. The baseline configuration has been defined by the written procedures or materials contained in manuals, standards, instructions or engineering drawings. If it is necessary to temporarily depart from the authorized configuration baseline, the contractor shall submit a Request for Deviation or Request for Waiver. MIL-STD-973 (paragraph 5.4.3 or 5.4.4) may be used as a guide.

3.4 PACKAGING, HANDLING STORAGE AND TRANSPORTATION (PHS&T).

a. The Contractor shall be responsible for preservation and packaging of the item(s) being repaired under the terms of this statement of work. Items scheduled for long-term storage or shipment to overseas destinations shall be in accordance with the level A requirements of MIL-STD-2073-1C, Method 41. Items scheduled for domestic shipment, immediate use or short-term storage shall be in accordance with level B requirements.

b. Marking shall be in accordance with MIL-STD-129.

c. The Marine Corps will provide the contractor with the shipping address(es) for delivery of the repaired equipment. The contractor shall be responsible for arranging for shipment to the pre-designated site(s). The Marine Corps will be responsible for transportation costs associated with shipping the subject equipment to and from the Contractor.
