

STATEMENT OF WORK FOR THE
Rebuild of the Synthesizer/AF Module
for the RT-1113A/PRC-68A
NSN 5999-01-191-0073

1.0 SCOPE This Statement of Work (SOW) identifies the work effort that shall be performed to rebuild/ overhaul the Synthesizer/AF Module, NSN 5999-01-191-0073, of the Receiver-Transmitter RT-1113A/PRC-68A.

2.0 Applicable Documents Unless otherwise specified, the issues of these documents are listed in the Department of Defense Index of Specifications and Standards (DoDISS) and supplement thereto which is in effect on the date of solicitation.

3.0 REQUIREMENTS

3.1 The Synthesizer/AF Module shall be rebuilt/overhauled in accordance with RS 06827B-50.

3.2. Quality acceptance and test shall be completed in accordance with RS 06827B-50.

3.3 Packaging, Handling, Storage and Transportation (PHS&T)

a. The Contractor shall be responsible for preservation and packaging of items being rebuilt under the terms of this statement of work. Items being prepared for long term storage or shipment to overseas destinations shall be level "A" in accordance with MIL-STD-2073-1C, Appendix J, Table J.Ia., Specialized Preservation Code "GX." Items being prepared for domestic shipment and immediate use shall be to level "B" requirements. Items subject to damage by electrostatic discharge shall be packaged into a resalable fast-pack container.

b. Marking shall be in accordance with MIL-STD-129.

c. The Marine Corps will provide the contractor with the shipping address(es) for delivery of the rebuilt equipment, and the contractor shall be responsible for arranging for shipment to the pre-designated site(s). The Marine Corps will be responsible for transportation costs associated with shipping the subject equipment to and from the Contractor.

3.4 Configuration Control The baseline configuration has been established in RS 06827B-50. Any approved Modification Instructions and Engineering Change Proposals that have not been implemented, shall be implemented. No deviation from the baseline configuration shall be allowed, unless authorized in writing by the Marine Corps Logistics Base (Code 847-1), Albany representatives. If there is need to temporarily depart from a configuration items characteristics, the contractor shall prepare and submit a Request for Deviation/Request for Waiver. MIL-STD-973 (paragraph 5.4.3 or 5.4.4 and Appendix E) may be used as a guide.

3.5 Quality Assurance Provisions The contractor shall provide and maintain a Quality System that, as a minimum, adheres to the requirements of ANSI/ISO/ASQC Q9003-1994, Quality System Model for Quality Assurance in Production, Installation, and Servicing.

3.6 Government Furnished Equipment (GFE)/Government Furnished Materiel (GFM) GFE is government owned equipment authorized by contract for use by a commercial/Government contractor. It is neither consumed during production nor incorporated into any product. GFM is materiel furnished to a contractor that will be consumed during the course of production or incorporated into the product being manufactured/remanufactured under a contract/statement of work. In the event the Marine Corps does have GFE/GFM requirements the Management Control Activity (MCA/Code 822), Marine Corps Logistics Bases, Albany, Georgia, will coordinate required GFE and will maintain a central control on Marine Corps assets in the Contractor's possession. The MCA will forward a GFE Accountability agreement to the Contractor Facility for signature to establish a chain of custody and property responsibilities for Marine Corps assets. The Contractor shall report receipt of all GFM and report consumption to the MCA.

3.7 Contractor Furnished Materiel (CFM) The Marine Corps has adopted the Navy's procedures regarding Contractor Furnished Materiel (NAVICPINST 4491.2A). In the event that Contractor Furnished Materiel is required for repair parts, the contractor shall requisition through the DOD Supply System. DOD 4000.25-1-M, MILSTRIP Chapter 11 authorizes contractors to requisition through the DOD Supply System.
