

STATEMENT OF WORK FOR THE
Rebuild of the ADVANCED NARROWBAND DIGITAL VOICE TERMINAL
AN/USC-43(V)2
NSN: 5895-01-252-7359

1.0 SCOPE. This document contains requirements to restore the Advanced Narrowband Digital Voice Terminal, AN/USC-43(V)2, NSN 5895-01-252-7359, Part Number ANUSC43V2, CAGE 80058 to Condition Code "A". Condition Code "A" is defined as "serviceable/issueable without qualification, new, used, repaired or reconditioned materiel which is serviceable and issueable to all customers without limitation or restriction, including materiel with more than 6 months shelf-life remaining.

1.1 This Statement of Work (SOW) identifies the work effort including repair, testing, and packaging/marketing requirements that shall be performed by the contractor to rebuild the Advanced Narrowband Digital Voice Terminal, AN/USC-43(V)2, NSN 5895-01-252-7359, Part Number ANUSC43V2, CAGE 80058.

2.0 Applicable Documents. The following documents form a part of this SOW to the extent specified. Unless otherwise specified, the issues of these documents are those listed in the DoD Index of Specifications and Standards (DoDISS) and supplement thereto which is in effect on the date of solicitation. In the event of conflict between the documents referenced herein and the contents of this SOW, the contents of this SOW shall be the superseding requirement.

3.0 Requirements

3.1 The Contractor shall rebuild the Advanced Narrowband Digital Voice Terminal, AN/USC-43(V)2, NSN 5895-01-252-7359, Part Number ANUSC43V2, CAGE 80058 in accordance with TM-09090A-35&P/3.

3.2 Packaging, Handling, Storage and Transportation (PHS&T)

a. The Contractor shall be responsible for preservation and packaging of items being repaired under the terms of this statement of work. Items being prepared for storage or shipment shall be level "A" in accordance with Special Packaging Instruction (SPI) 10130. This instruction may be obtained from G3 Logistics Operations Department, Attn: S&DD (G330), 814 Radford Blvd. Suite 20330, Albany, Georgia 31704-0330, Commercial (912) 439-6856 or DSN 567-6856. Items being prepared for domestic shipment or immediate use shall be to level "B" requirements.

b. Marking shall be in accordance with MIL-STD-129.

c. The Marine Corps will provide the Contractor with the shipping address(es) for delivery of the rebuilt equipment. The Contractor shall be responsible for arranging for shipment to the pre-designated site(s). The Marine Corps will be responsible for transportation costs associated with shipping the subject equipment to and from the Contractor.

3.3 Configuration Control. The Contractor shall apply configuration control procedures to established configuration items. The Contractor shall not implement configuration changes to an item's documented performance or design characteristics without prior written authorization from the Weapon System/Equipment Manager (Code 847-3). If it is necessary to temporarily depart from the authorized configuration, the contractor shall prepare and submit a Request for Deviation/Request for Waiver. MIL-STD-973 (paragraph 5.4.3 or 5.4.4 and Appendix E) may be used as a guide.

3.4 Government Furnished Equipment (GFE)/Government Furnished Materiel (GFM). GFE is government owned equipment authorized by contract for use by a commercial/government contractor. It is neither consumed during the production nor incorporated into any product. GFM is materiel furnished to a contractor that will be consumed during the course of production or incorporated into product being manufactured/remanufactured under a

contract/statement of work. In the event the Marine Corps does have GFE/GFM requirements, the Management Control Activity (MCA/822), Marine Corps Logistics Bases, Albany, Georgia, will coordinate required GFE and will maintain a central control on Marine Corps assets in the Contractor's possession. The MCA will forward a GFE Accountability agreement to the Contractor Facility for signature to establish a chain of custody and property responsibilities for Marine Corps assets. The Contractor shall report receipt of all GFM and report consumption of GFM to the MCA.

3.5 Quality Assurances Provisions. The contractor shall provide and maintain a Quality System that as a minimum, adheres to the requirements of ANSI/ISO/ASQC Q9003-1994, Quality System Model for Quality Assurance in Final Inspection and Test.

3.6 Contractor Furnished Materiel. The Marine Corps has adopted the Navy's procedures regarding Contractor Furnished Materiel (NAVICPINST 4491.2A). In the event Contractor Furnished Materiel is required for repair parts, the contractor shall requisition through the DoD Supply System. DoD 4000.25-1-M, (MILSTRIP) Chapter 11 authorizes contractors to requisition through the DoD Supply System.
