



1.0 Scope. This Statement of Work (SOW) establishes, sets forth tasks and identifies the work efforts that shall be performed by the contractor to rebuild the AN/TPS-59(V)3 Column Feed, NSN 5840-01-145-4684, part number 7327460G1, CAGE 03538, hereafter referred to as the Column Feed. This document contains requirements to restore the Column Feed to Condition Code "A." Condition Code "A" is defined as "serviceable/issuable without qualification; new, used, repaired or reconditioned material that is serviceable and issuable to all customers without limitation or restriction, including material with more than six months shelf-life remaining."

1.1 Background. Rebuild is defined as "That maintenance technique to restore an item to a standard as near as possible to original or new condition in appearance, performance and life expectancy. This is accomplished through a maintenance technique or complete disassembly of the item, inspection of all parts or components, repair or replacement of worn or unserviceable parts/elements using original manufacturing tolerances and/or specifications and subsequent reassembly of the item."

2.0 Applicable Documents. The following documents form a part of this SOW to the extent specified. Unless otherwise specified, the issues of these documents are those listed in the Department of Defense Index of Specifications and Standards (DoDISS) and supplement thereto which is in effect on the date of solicitation. In the event of conflict between the documents referenced herein and the contents of this SOW, the contents of this SOW shall be the superseding requirements.

3.0 Requirements.

3.1 The contractor shall rebuild the Column Feed strictly in accordance with the requirements as specified in Engineering Drawing 7327460 and Parts List 7327460G1, CAGE 03538. Testing shall be conducted in accordance with Test Requirements 77A100750, CAGE 03538, and the test results shall be documented in a Test Data Report (TDR). The contractor shall be responsible for all parts, materials, labor, facilities, tools and test equipment necessary to rebuild the equipment in accordance with this SOW.

3.2 Packaging, Handling, Storage and Transportation (PHS&T).

3.2.1 The contractor shall be responsible for preservation and packaging of item(s) to be repaired under the terms of this Statement of Work. Items scheduled for long-term storage or shipment to overseas destinations shall be in accordance with level "A" requirements of MIL-STD-2073-1D, Appendix A, Table A.VI, Electronic Equipment. Items scheduled for domestic shipment for immediate use or short-term storage shall be in accordance with level "B" requirements.

NOTE: Level "A" preservation and packaging shall normally be required due to the anticipated long-term storage requirements. Exceptions: Items that have a confirmed immediate use requirement shall be identified; in writing, by the Logistics Management Specialist (LMS), MCSC (Code BMADS), Albany, Georgia.

3.2.2 Marking for shipment and storage shall be in accordance with MIL-STD-129.

3.2.3 The Marine Corps will provide the contractor with the shipping address(es) for delivery of the repaired equipment. The contractor shall be responsible for arranging for shipment to the pre-designated site(s). The Marine Corps will be responsible for transportation costs associated with shipping the subject equipment to and from the contractor.

3.3 Configuration Control. The contractor shall apply configuration control to established configuration items. Deviations from this established baseline configuration shall not be allowed without the express written approval of the Logistics Management Specialist (LMS), Code C4I. All permanent changes to the form, fit, or function of the baseline shall be by Engineering Change Proposal. If necessary to temporarily depart from the authorized configuration baseline, the contractor shall prepare and submit a Request for Deviation. MIL-HDBK-61 and ANSI/EIA-649 provide guidance for preparing these configuration control documents.

3.4 Government Furnished Equipment (GFE)/Government Furnished Materiel (GFM). The Management Control Activity (MCA/Code 573-2) will coordinate Government Furnished Equipment/Government Furnished Materiel (GFE)/(GFM) requests and maintain a central control system on all government owned assets in the contractor's possession. The MCA will forward a GFE Accountability Agreement to the contractor for signature on an annual basis to establish a chain of custody and identify property responsibilities for Marine Corps assets. The contractor is to acknowledge receipt of GFM to the MCA within 15 days of receipt. (This can be done by mailing (Materiel Management Department, Management Control Activity (Code 573-2), 814 Radford Blvd., STE 20320, Albany, GA 31704-0320) or faxing (commercial 229-639-5498 or DSN 567-5498) a copy of the DD1348).

3.5 Quality Assurance Provisions. The contractor shall provide and maintain a Quality System that, as a minimum, adheres to the requirements of ANSI/ISO/ASQC Q9003-1994, Quality Systems - Model for Quality Assurance in Final Inspection and Test.

4.0 Reports. The contractor shall develop a Test Data Report (TDR) in contractor format, referencing this SOW, the NSN, part number and serial number of the Column Feed. The TDR shall reference the specific paragraph of the Test Requirements 77A100750, CAGE 03538, for all "Performance Requirements" (i.e. the allowable parameters and quantitative test results). Upon request, a copy of the TDR shall be submitted electronically (preferred), via regular mail, or facsimile to the Logistics Management Specialist (LMS).
